Please find below a summary of actions taken or initiated by the State Medical Board of Ohio in February 2015 and an update of Board matters pending or decided in courts as of February 11, 2015.

CITATIONS/PROPOSED DENIALS

BEISTEL, Andrew John, DO (#34.009942) – Canfield, Ohio

Based on doctor's alleged violations of his August 12, 2010 Consent Agreement due to his failure to timely call in to the Board-approved drug testing facility, failure to appear for required urine screens and failure to submit documentation of attendance at alcohol and drug rehabilitation meetings. Notice of opportunity for hearing mailed February 12, 2015.

HOBOWSKY, Martin Richard, DO (#34.006544) – South Charleston, Ohio

Based on doctor's alleged violations of his April 2010 Consent Agreement due to his failure to submit quarterly declarations and his alleged failure to cooperate in an investigation. Notice of opportunity for hearing mailed February 12, 2015.

REDDY, Sheila Sandadi, MD (#57.020391) – Marion, Ohio

Based on doctor's alleged violations of her February 2013 Step II Consent Agreement due to her failure to timely call in to a Board-approved drug testing facility and failure to appear for required urine screens. Notice of opportunity for hearing mailed February 12, 2015.

THOMAS, Edward A., PA (#50.000449) – Kent, Ohio

Based on the physician assistant's alleged violations of the Board's statutes and rules regarding prescribing of controlled substances in the care of three patients. Notice of opportunity for hearing mailed February 12, 2015.

WEST, Joseph Matthew, MT (#33.021623) – Trenton, Ohio

Based on the massage therapist's alleged violations of his January 2014 Step I Consent Agreement due to his failure to contract with a Board-approved drug testing facility, failure to timely call in to the Board-approved drug testing facility, failure to submit to urine drug screens, failure to submit quarterly declarations, failure to appear before the Board for an in-person interview, and failure to participate in an alcohol and drug rehabilitation program. Notice of opportunity for hearing mailed February 12, 2015.

FINAL ORDERS

BELL, Phyllis Y., (MT applicant) - Cuyahoga Falls, Ohio

Application for license to practice massage therapy granted and immediately suspended for at least 180 days, subject to conditions for reinstatement and probationary terms for a minimum of three years. Based on the applicant's 2010 conviction in the Franklin County Court of Common Pleas on one felony count of theft; prior action by the Ohio Board of Nursing which suspended the applicant's license to practice as a licensed practical nurse for at least five years; and on the applicant's prior conviction in 1983 of Receiving Stolen Property. Effective March 10, 2015.

BRUNO, Patrick Lewis, MD (#35.096568) - Van Wert, Ohio

Medical license subject to probationary terms, conditions and limitations for at least three years. Based on prior action by the Missouri Board of Registration for the Hearing Arts, which issued a probated license with a disciplinary period of three years based on the doctor's failure to disclose on his application for a license that he had two alcohol related arrests and/or convictions and his failure to disclose his habitual intoxication or dependence on alcohol and on prior action by the Division of Professional Regulation of the Department of Financial and Professional Regulation of the state of Illinois which issued an order refusing to renew the doctor's license. Effective February 12, 2015.

KINCAID, Richard M., MD (#35.046361) – Westerville, Ohio

Probationary terms, conditions and limitations in October 13, 2010 consent agreement extended for a minimum of one year. Based on the doctor's violations of limitation placed on his license pursuant to the October 13, 2010 consent agreement due to the doctor's failure to timely call in to a Board approved drug testing facility or failure to present to a collection site on multiple dates in 2013 and 2014. Effective March 3, 2015.

SAMUELS, Todd Louis, M.D. (#35.125724) – Baltimore, Maryland

Medical license granted and reprimanded. Based on prior actions against the doctor's licenses in the states of California, Illinois, Louisiana, Maryland, New Jersey, Pennsylvania, Virginia, and Florida. Effective February 12, 2015.

VOLUNTARY SURRENDERS/RETIREMENTS/WITHDRAWALS

BALDWIN, James Bruce III (DPM applicant) – Beaver Falls, Pennsylvania

Permanent withdrawal of licensure application authorized by podiatric physician applicant in lieu of formal disciplinary proceedings pursuant to Sections 4731.22(B)(26), Ohio Revised Code. Effective February 11, 2015.

CONSENT AGREEMENTS

HUGHES, David Michael, D.O. (#34.005786) – Defiance, Ohio

Medical license suspended for at least 180 days with interim monitoring conditions and conditions for reinstatement established, including requirement that doctor enter into a

subsequent consent agreement incorporating probationary terms, conditions and limitations as determined by the Board. Based on admissions that in his care and treatment of five specified patients, the doctor failed to maintain minimal standards applicable to the selection or administrative of drugs; departed from or failed to conform to minimal standards of care; failed to keep medical records relating to his treatment and prescribing; and utilized controlled substances in his treatment of family members in violation of Medical Board rules. Effective February 11, 2015.

LEUNG, Steve Mingfung, MD (#57.019737) – Cleveland, Ohio

Training certificate suspended for at least one year and subject to interim monitoring conditions and conditions for reinstatement established, including requirement that doctor enter into a subsequent consent agreement incorporating probationary terms, conditions and limitations as determined by the Board. Based on admissions that he is impaired in his ability to practice according to acceptable and prevailing standards of care because of habitual or excessive use or abuse of drugs, alcohol, or other substances that impair ability to practice and the commission of acts constituting a felony. Effective February 11, 2015.

PATEL, Dennis A., MD (#57.017700) – Toledo, Ohio

Training certificate reinstated subject to probationary terms, conditions and limitations for at least five years. Based on doctor having completed all requirements for reinstatement of license pursuant to the terms of a December 10, 2014 consent agreement. Effective February 11, 2015.

SWANSON, Shannon Lee, DO (#34.008887) – East Springfield, Pennsylvania

Osteopathic medical license reinstated subject to probationary terms, conditions and limitations for a minimum of three years. Based on admissions of violations of the Board's statutes and rules regarding prescribing of controlled substances in the care of eight individuals. Effective February 11, 2015.

Permanent non-disciplinary surrender of medical license authorized by doctor in lieu of continuing compliance with the terms of the September 2014 Board Order. Effective February 11, 2015.
